# **OLD BUSINESS**

#### Fair:

Many class changes were discussed. The following were the decisions for class changes:

Bareback classes will now be listed as either "Bareback Equitation" or "Bareback Horsemanship."

Amy made a motion to add a ranch showmanship, ranch horsemanship, walk-trot ranch horsemanship, and walk-trot ranch pleasure. April seconded. Motion passed.

Cross rails divisions were added to both the Working Hunter and Equitation over Fences classes. There was *not* a cross rails division added to Hunter Hack at this time.

Versatility and years in 4-H - rule was repealed about the number of years required to be in 4-H. Advisors should determine whether the member can safely participate in this class, as with all classes.

Driving class order - was discussed and decided to re-evaluate after the 2021 fair.

Versatility classes- will add each component to the showbill so the judges (and exhibitors) know what classes are a part of Versatility.

Dressage - Walk trot will no longer be an option. There will be a designated test for the class - USEF Training Level Test 1 and this will be listed on the showbill.

#### Rules:

Will add the rule to the Equine King and Queen Contest - The contestant must have shown Equine the prior year the Darke County Junior Fair.....

Will add Mule Equitation and Hunter Under Saddle. We agreed to do away with the Mule Showmanship and Horsemanship championship. The top three from Mule Showmanship, Horsemanship, and Equitation will go into the appropriate age group championship classes. The title of these classes will be changed to include the word Mule (Example - "Senior Horse & Mule Showmanship Champion")

## **NEW BUSINESS**

**Skillathon -** Offering two options for the skillathon was discussed, but tabled until the next meeting.

**Record Books-** Anyone who would like to have their record books reviewed by Rhonda should submit them by the end of the year. Each individual club can do their own awards for outstanding record books, if they would like.
