Amy asked the JFB if it would be possible to order smaller sashes for the Prince and Princesses for next year.
- **Sr. Fair Board Report:** Nothing to report.
- **Jr. Fair Coordinator Report**: Beth's contract was not renewed. Rhonda will be filling this position in the interim. Anyone interested in information about the position should contact the fair office.
- **4-H Youth Development Report:** Rhonda stated that virtual meetings are recommended and preferred. In person sessions can be held when there is an educational aspect. All participating must social distance and wear a mask when applicable. Enrollment for 2021 will be online.

OLD BUSINESS

Fair: Jumping safety check - Amy suggested that we have a safety check off for jumping classes. There was discussion and it was decided that this should remain the responsibility of the advisors at the club level.

Rules and class changes will be discussed at the next meeting.

Timers- Angie Young asked Brian Rismiller if it would be okay to install a piece of sheet metal on two fence posts for our magnetic timers. Brian Rismiller stated that this would be okay.

Food Stand - Will plan to buy drinks and ice for the judge, announcer, and ring master next year to save money at the food stand. There was discussion about also using vouchers for the food stand or asking the food stand to write down the names of those who get food.
